

Innogy Renewables UK Middlemoor Wind Farm Community Benefit Fund Will open for applications on Monday 20 January 2020

The deadline for submitting applications is Monday 24 February 2020 for consideration at the Panel meeting in April 2020

Applications are invited for the Innogy Renewables UK Limited Middlemoor Windfarm Community Benefit Fund at the Community Foundation.

Area of benefit:

- Priority consideration will be given to applications from individuals, groups, projects and activities based within the Parish of Eglingham.
- Consideration will also be given to applications from groups and organisations outside of Eglingham Parish that provide services and activities that are deemed by the Fund to be of benefit to residents of the Parish.

Groups can apply for a minimum of £250 up to £81,000. Individuals can apply for a minimum of £250 up to a maximum of £2,000, subject to periodic review.

Who can apply?

- Individuals resident within the Parish of Eglingham.
- Constituted voluntary, community groups and charities based within the Parish of Eglingham.
- Consideration will also be given to constituted voluntary, community groups and charities which operate outside the Parish, if they can demonstrate that the project benefits people living within the Parish of Eglingham.

What can be funded:

- The fund will consider requests for both capital and revenue funding.
- The Fund will support requests that are charitable, educational, philanthropic and benevolent in purpose.
- It will make grants to community groups, voluntary/charitable organisations and schools (for non-statutory purposes only).
- Capital items with tangible, lasting benefit, including improvements to community buildings.
- Biodiversity and habitat conservation.
- Energy conservation and increased use of renewables.
- Other projects which are community based and/or community led.

Examples of what grants will be supported:

- Capital items (buildings, machinery, equipment, vehicles and tools etc.)
- Time limited revenue requests.
- Sessional worker costs, e.g. workshops, tutors.
- Repairs and/or refurbishment to community buildings.
- Start-up costs for new community groups.
- Out-of-school activities.
- Voluntary and community group activities.
- Community and environmental projects.
- Educational bursaries, apprenticeships, training courses.

This list is not exhaustive and all applications will be given due consideration by the advisory panel.

What will not be funded:

- Retrospective grants.
- Activities that are the current responsibility of statutory authorities (e.g. School curriculum activities, road repairs etc).
- Political campaigns.
- Religious campaigns.
- Individuals full-time resident outside the parish of Eglingham.
- Projects, activities within the parish of Ellingham (for so long as a dedicated community wind farm benefit fund exists within Ellingham Parish).
- Projects whose purpose is to generate income for personal gain.
- Repayment of loans or debts.
- Funding for third party distribution.
- Anti-renewable energy/windfarm activities.
- Activities likely to bring the reputation of the Community Foundation or Innogy Renewables UK Ltd or its subsidiaries into disrepute.

Have your say on the future of library services in Northumberland

People in Northumberland are being asked for their views on the future shape of library services in Northumberland.

The county council has launched a public consultation, which went live on Wednesday 18 Dec, asking for people to submit their comments and ideas of how the service should be delivered in the future.

The consultation is open to all, whether they are a regular library user or not, and the council is also engaging with schools in order to get the opinion of youngsters in the county.

People have until March to respond to the questionnaire which is available at https://www.surveymonkey.co.uk/r/NCCLibraryConsultation and as a paper copy in all libraries in the county.

It is hoped the consultation will help identify the most valued aspects of the service and the barriers to library use across the county. The results of the consultation will help the council focus on how the service is delivered in the future.

As a statutory service the council is required to carry out a public consultation exercise if changes to the service are proposed.

A series of drop-in sessions will also be held for residents to ask questions or provide verbal feedback.

GRIT BINS

Grit bins are available on selected steep hills, verges, sharp bends and near steps, particularly where routine gritting does not happen.

NCC supply 1,600 bins for the public to use, which they restock as often as possible during the winter. You can use the grit provided to clear snow and ice from pavements around your home, making paths safer and easier to use.

• Follow the government's guidelines on clearing snow from roads, paths and cycleways to do this safely.

Grit provided should not be used for treating private property.

SNOW CLEARANCE ON ROADS

When snow falls in excess of 50mm, with possible drifting, snowploughs attached to gritters will be used. Snowblowers and other specialist machines are also sometimes used.

In severe snow conditions it's not possible to clear all the roads at once, so NCC prioritise roads in the following order:

- 1. principal roads cleared to a minimum two-lane width
- 2. roads into towns and villages at least one road into each to allow for access to the cleared major roads
- major town centres

Snow clearance on other roads will only take place when the higher priority roads have been cleared which may take several days.

Eglingham Parish Council

Wednesday 15th January at Eglingham Village Hall.

There had been a request for an extra bus stop at West Link Hall, North Charlton. County Cllr Pattison said she had received an email from Neil Easton, the bus stops officer, explaining a bus stop would not be put at West Link Hall because it was felt it would be dangerous to do so. This was accepted by the PC.

<u>Land to East of St James Church, South Charlton</u>. The clerk had received a few responses from residents of South Charlton. One was in favour of the plans, two expressed concerns about the access on a busy corner and a final comment was querying if the construction would by fully stone. A decision on the next step was made under the item on Eglingham Neighbourhood Plan.

Eglingham Traffic Management Plan The chair said 6 representations had been received following the consultation all in favour of the proposal but concerned that the signage is not too intrusive in a Conservation area. Cllr Biesterfield had had correspondence from residents concerned about the plan for a footpath on the bridge when they consider the existing arrangements satisfactory. Cllr Alston said the footpath was something the PC had been looking at getting for the last 12/13 years. Cllr McIver felt that the PC had a duty of care to proceed with the plan when there was increased traffic through the village. Cllr Alston also highlighted that the money to do the bridge had been offered in this year's budget which would finish at the end of March. It was agreed the clerk will contact Council officer Richard McKenzie to ask for clear details about signage to arrange a site meeting at Eglingham. Cllr Alston said if need be an extraordinary meeting could be called.

Eglingham Neighbourhood Plan update: Cllr Biesterfield said that the Groundwork grant of £7000 had been received and work could start with the landscape consultant although due to the darker nights he felt this would take time and would next expect it to be completed before the end of March. The Design Code was also set to be undertaken as the technical support had been formally agreed and approved consultants appointed. He expected work to commence on this at the end of January or most likely early February. Cllr Biesterfield stressed the importance of involving Northumberland Estates in light of their proposed application for housing at South Charlton. He urged that the Estates take account of the Design Code in their planning application even if this meant a delay in submitting to NCC. It was resolved that Cllr Biesterfield will contact Colin Barnes, head of planning and development at Northumberland Estates, to discuss the Design Code and EPC's response to the proposed plans to date. Cllr Biesterfield said it was likely to be May before the Neighbourhood Plan was at a stage to consult publicly on its draft policies.

Cllr Biesterfield highlighted that the Northumberland Local Plan was holding a hearing on February 6th regarding its windfarm policy. He urged that as many Parish Councillors and Parishioners as possible attend the meeting to show the community feeling against the policies.

<u>Middlemoor Community Windfarm</u>; Cllr Alston said that he would be standing down as a panel member on the Windfarm grant board in April. The Community Foundation is keen that the Parish Council is represented on the panel which meets three times a year. Cllr Alston asked that councillors consider for the next meeting.

Highways Matters; Tarry Road- the gully cleaner had been out and cleaned a section of Tarry road and had resolved the problem of water flooding from the wall at the entrance to Tarry. However Nigel Brannen at NCC had informed the clerk that there was a bigger issue and Tarry Lane had been added to the drainage programme. It was agreed the clerk will query what this means. Potholes, Cllr Pattison had raised concerns about potholes on the South Charlton road heading towards Eglingham Road, Cllr Lawson had raised concerns about potholes on Shipley Road and other councillors complained about the number of potholes on the Eglingham to Alnwick Road. The clerk will write to Highways regarding all matters.

<u>Neighbourhood Police officer</u>; A new Neighbourhood Police Officer Paul Sykes had been appointed for the area and the clerk will send the PCs meeting dates in case he can attend while on shift.

The next meeting of the Parish Council will be held on Wednesday February 26th at South Charlton Village Hall.

Henry Knotts



On the 18th of December 2019 the family and wider community of Eglingham and area packed St Maurice's Church in Eglingham to remember and celebrate the life of Henry Knotts who had recently died at age 55.

Henry was a well known character to the people of Eglingham and to anyone who regularly travelled the Alnwick to Eglingham road as he frequently hitched between the two. Often seen as a lone figure, out in all weathers, often wearing his well worn yellow fluorescent waistcoat, thumb held high hoping to get a lift to or from Alnwick, where he would avidly watch football in one of the local pubs.

Henry was born and bred in Eglingham and spent all his life in the village. He was a life-long supporter of Newcastle United, celebrated at his funeral with the black and white wreaths from his family.

Anyone who had given a lift to Henry would know that he had a remarkable ability to remember dates of when people moved to the village, birthdays and football scores. How many of us were asked during a car journey "do you know whose birthday is only once every four years"?

Living opposite Henry, we first met him, when he came knocking at the door asking to use our phone. This became a regular occurrence and whilst using the phone he used to enjoy stroking our cats, but only the 'friendly' one as he called her.

On other occasions his visits could be more dramatic, knocking on the window late at night to borrow a ladder. He had locked himself out. Standing watching a slightly enebriated Henry unsteadily climb the ladder to a first floor window then disappearing head first, legs squirming, as he slid through the window was a sight to behold.

Henry was a character and will be remembered by a large number of people evidenced by the packed church for his funeral. Even now driving intro Alnwick I still half have the expectation of seeing that yellow clad figure thumb held high waiting for a lift.

THE RANT by Peter Marriott-Lodge

As some readers will know, my house is next to harehope Bridge. both myself and my neighbour opposite, James, are very concerned about the proposed, so called improvements, to the traffic flow over the bridge to increase safety. The bridge has been there for over a hundred years and I have search high and low to find a reported incident involving either a wagon, bus, car cart, bicycle, pedestrian, either sober or drunk, a dog a cat or even a duck that has been involved in an incident on the bridge. I have not been successful and that is because there has not been one.

The reason why there has not been one is very simply because the approach roads to the bridge are straight in both direction and therefore all that is required is a degree of common sense when approaching the bridge. Something the council appears to be lacking. Not even a pheasant, which as we all know, are not known for their high IQ have not managed to get themselves killed on the bridge which is more that can be said for the road from alnwick, commonly known as 'suicide alley'.

I made the mistake of voicing my opinion on this matter in public and two days later I received the following letter. (We hope you have good eyesight to read this humerous letter! We'll put it on the website version in full size so you can read it easier - Ed.)

Dear Mr. Marriott-Lodge,

Re: Harehope Burn Bridge pedestrian safety upgrade, Eglingham village

I am writing to inform you that my Department has recently been contacted by Anne-Marie Travelyan, MP who raised your objections to the planned improvements to traffic flow arrangements across the Harehope Burn Bridge in Eglingham.

As I explained to Mrs Travelyan, these proposed arrangements had been drawn up to help ensure public safety while crossing the bridge, which currently does not incorporate pavements and therefore poses a very serious safety hazard to pedestrians.

Having spoken at length with Mrs Travelyan and listened carefully to your concerns, I can now inform you that we have decided to withdraw these original proposals and that we have approved and are in the process of actioning an alternative scheme. This requires the existing bridge to be demolished entirely and a more suitable replacement to be constructed on the same site.

As ensuring pedestrian safety is of paramount concern to us all, I hope you will be as pleased as I am to learn that the new bridge will be 21.75 metres wider than the existing structure. It will feature covered, airport-style mechanical walkways on both sides, central crash barriers, floodlighting along the entire length of the bridge and for 50 metres of the B6346 in either direction of approach, as well as sensor-activated klaxons and flashing warning lights to alert pedestrians to approaching traffic.

In addition, it will include a rolling convoy facility which can be deployed at busier times of the year, for example during the summer months when more tourists are around and at night when agricultural vehicles such as combine harvesters and associated heavy machinery require unimpeded transit through the village.

The large, tank-style escort wagons that facilitate such convoy systems will need to be accessible to operatives at all times, and as a result we are intending to construct appropriate garaging and maintenance amenities at the site. As part of our commitment to offer the most cost-effective services to residents of the county, these sheds will also

be used to accommodate the fleet of road gritters we will be relocating there, and will include living quarters for up to 12 drivers.

I regret this means we will need to compulsory purchase a significant (95%) area of your land, as well as dam the stream and re-route it under your house. Plans for this work can be viewed (by appointment only) at Blueprint House, Nackers Lane, London W1 on every fifth Friday afternoon between the hours of 17:00 and 17:10. If you wish to inspect these, please contact the Department for Pedestrian Rights on 020 8572 606 Ext. 101.

As you will see from the plans, the approved designs for the bridge are sympathetic to its location and are intended to reflect the heritage of the region. Constructed entirely out of steel, concrete and glass, it will, when completed, be a contemporary version of the world-farmous Tyne Bridge in Newcastle upon Tyne, with a discrete, 75-metre-tall telecommunications mast on top of it.

The initial phase of work is to be actioned immediately and I appreciate that for a period of time this may impact on your quality of life, as well as your ability to access your property. However, please be assured that we calculate all works should, hopefully, be completed within a modest 72-month timeframe.

Finally, our records show that the Minor Waterways (Traversing) Act of 1771 enshrines in Law that owners of the land on which your house stands have a legal obligation to provide assistance to anyone wishing to cross the Burn. I am therefore required to inform you that once the existing bridge has been demolished and its replacement constructed, you, your family and anyone you are subsequently able to sell your house to will have a legal responsibility to provide free food, refreshments and accommodation to pedestrians who demand it. In accordance with the stipulations of the Minor Waterways (Traversing) Act, a high-visibility sign will be displayed at either end of the new bridge to inform them of this right.

Once in place, we are confident that the new bridge and its state-of-the-art facilities will guarantee pedestrian safety across Harehope Burn, which I'm sure you will agree should take precedence above all other considerations. As such, I trust that this matter is all now acceptable to you. However, should you have any further questions or objections I would advise you direct them to Mrs Travelyan who has agreed to ignore them entirely.
