

## What do you think?

The Parish Council ('PC') has, amongst a number of other projects underway, two on which it would welcome the views of residents.

First, we propose a second speed warning sign (N.B. not a speed camera) at the south-eastern end of Eglingham, funded by the Community Council, and broadly replicating that at the north-western end of the village. The County Council has already given its in-principle consent. The photographs, below, show roughly where the camera will be located – just before or around the bottom of the Terrace, heading north.





Second, the Eglingham Community Association has sought and received the PC's support for the thorough refurbishment of the Eglingham bus shelter which the PC owns. Again, the Community Association will be asked to fund the works but there is one issue on which there is some apparent disagreement: should the litter bin, presently located within the shelter, stay there or be moved to its previous location, attached to the adjacent telegraph pole (it is envisaged that it would be attached so as to be beside rather in front of the pole – what do you think (again, see the photographs, below)?





Those in favour of moving the bin from inside the shelter argue that, especially in the summer, the bin, which has a fairly wide aperture, attracts wasps and flies to the detriment of those using the shelter – especially, children.

Those wishing to leave the bin inside the shelter argue that it is less obtrusive, there, an important issue in the Eglingham Conservation Area.

By not later than 21st February, please let the PC have your views on both the speed warning camera and its location and on whether the bin should be inside or just outside the bus:

This is an informal consultation to which the PC, while not bound by the results, will have regard in its decisions on both matters.

## Eglingham Village Hall Acoustics

The acoustics issue in the hall due to noise echoing around will have been recognised by many, over the years, whether having had difficulty making out what actors are saying at film nights, hearing clearly what is being said into a stage microphone or even hearing clearly all that is said at meetings.


The Committee agreed to employ an independent noise consultant and NOVA Acoustics were chosen from a shortlist to carry out a test with a view to identifying what could be done to improve things. They have an impressive list of previous clients including Universities of Oxford, Leeds and Essex, Unilever, Savills, Persimmon, ITV and Interserve, to name but a few.

Nova Acoustics carried out a test in November. Some of the main points from their report are as follows:

- Reverberation (Echo) times are shown in terms of something called "Tmf" and a satisfactory measure for our multi-use hall would be 0.8 1.2 Tmf
- The test showed that there is presently a mid-frequency Tmf of 1.8, clearly much higher than what is recommended. This reading confirms the problem.
- To reduce the Tmf to an estimated 0.93, NOVA's recommendation is to install 35 sq m of Class A Sound Absorbent panels on the walls and or ceilings
- To further reduce the estimated Tmf to 0.8 ie the bottom of the target range a further sq m of panels could be installed.

We are proceeding with the installation of acoustic panels on the walls as per the following illustrative mock-up.

There will also be acoustic panels either side of the stage plus one above the doorway



where the clock is situated. This will achieve in total 34.8 sq m of panels. We could then see how this improves things and it may well be that no further action is required.

If however it was felt that additional panels were necessary, then NOVA's recommendation is to utilise the ceiling for additional panels.

One side benefit of the panels could be that they have an insulating effect making heating up the hall even quicker!

Nova suggested various suppliers and there are numerous panels to pick from. The supplier that we did obtain a quotation from was JCW who were the only supplier able to provide  $3m \times 1.2 m$  panels which is the size shown in the mock-up. The sound absorbent panels are 50mm thick..

In terms of panel colours, it will be a neutral colour called "Lomond" which you can find on the Cara - Camira Fabrics website, should you wish to see it.

The acoustics will also be helped to a degree by the fitting of stage curtains.

The Committee are hopeful that a grant application to the RWE Windfarm Fund would be successful and we are looking forward to the time when poor acoustics will be a thing of the past.

## Checking the sheep on 5th January 2022

Sun glinting off the ice, I crunch and slide my way to the quad on one of those glorious winter mornings you get all too few of. Sharp clear air, no wind and me wrapped and swaddled to keep out the cold.

Away we went, gingers lolloping alongside the bike, past the house heading for open fields. I see a pile of chicken feathers at the side of the road, laid out in a circle. I had a quick look, but could not find a body. Reckon I will have lost one there.



Into the fields, I head up the hill. The gingers stretch their legs, enjoying the morning run on a nice firm surface. Sticking to drain lines and rig crests, the bike moves smoothly over the frost filled ground. Then, out of the little pinewood on my left, a Buzzard rose, languorously unfurling long brown wings. It took a few pulls to get going; then wheeled away over the storm smashed wood

down below, where the chickens make their home. Hmmm. Feathers, eh? There seem to be quite a few Buzzards around. I have seen them all the way to the Herds House turn off, not so much after that. Partridges, I suspect. But my, they are a fine sight. A friend of mine down in the Shipley mires used to watch them through a spyglass, spiralling on thermals higher and higher. Said the most he ever saw was nine.

I am heading to the Top Moor, cunningly named, no? It is a 60-acre field of moorland at the top of the farm. They didn't miss a trick when naming the fields, did they? When did it happen? Was there a naming of the field's day, when MAFF decreed that henceforth you had to give them a name?

Through the gate with the large pool underneath, frozen solid today. The hounds

bounce and slide. A cloud of Oystercatchers lift as one right in front of me, dappled things in all their glory. I have never seen as many together. I just sat on the bike, quietened the dogs and watched as they took themselves a little further up the hill, hovered, and settled down again. They are on the RSPB's Amber watchlist, there being a shortage of them nationally. I don't think they ever look in




Northumberland when doing these bird counts. I was in Slaggyford one February a few years back, and the sheer number of migratory ducks, geese, waders, plovers and numerous other species was staggering to behold. Round here, the goose music from the sky of an evening as flocks head off to the coast just makes the heart sing.



Down the hill and off the moor, I am passing alongside a sevenacre wood where once I saw a Green Woodpecker dipping and looping, red cap shining. Nothing today, but several hares dart out of the way of the gingers who thankfully choose not to bother. And that is it for the morning. Back home, where five

hens line the side of the road demanding their breakfast. All present and correct. One of them is moulting and must have been plucking herself. Nothing dead at all. A good morning in the Parish of Eglingham.

DOUBLE BOULDER STONE TWO SISTERS, TWO CHURCHYARDS, TWO GRAVESTONES, TWO BOULDERS

High in the Cheviot hills are two old shepherd's houses. In the late 19 century, Milkhope was the home of the Anderson family (now an outward-bound centre in Kidland Forest), and their great friends and neighbours, the Armstrong's, lived just a few miles away across the moors at High Blakehope (now Bleakhope Farm) in the Breamish Valley.

Two of the Anderson's girls (there were 10 children altogether) have similar, but unusual gravestones. Both went from Milkhope to work as domestic and farm servants at the Armstrong's farm. The younger sister, Isabella (Tibbie), stayed at Blakehope and married one of the Armstrong sons. Tibbie



was well known in Cheviotdale for her hospitality and lived to be 88. The couple's gravestone is in Ingram churchyard.

The elder sister, Elizabeth, moved on to work in Eglingham. She died tragically in 1875 of Typhoid fever aged only 22. Caused by poor sanitation and spread by bacteria in contaminated food and water, it can cause serious medical complications, but in Elizabeth's case it was fatal. Elizabeth's gravestone is close to the main gate of St Maurice's churchyard in Eglingham. It has been placed on top of what is thought to be a medieval cross socket base.

Both sister's gravestones were constructed from two huge granite boulders placed one on top of the other. The stones, rounded by thousands of years of water erosion, were carefully chosen by their families from the River Breamish close to the special place where they'd both lived.

### Storm Arwen

Who knew that Arwen would be canonised to become St. Arwen the patron saint of wood burning stoves.

The storm that swept across the northern and eastern part of Britain on 26th November has certainly changed the landscape with vistas appearing not seen before and many woods decimated. And a vast amount of damage to buildings, farm and industrial sheds etc. Normally it would be said the damage was incalculable but as I go round my farmer customers, calculations are indeed being made. There won't be a farmer between Aberdeen and Durham that won't be making an insurance claim. I know off, having been marginally professionally involved, of claims in excess of a million. Loss adjusters are being almost bussed into every farm and getting best china treatment. I dread to think what this will do to NFU Mutual's coffers, watch out when premium renewals come in next year! However, it's got to be said that the NFU are being justly lauded for their extremely prompt, fair and sympathetic treatment of insurees.

The stories of Arwen's havoc are becoming legendary:- the farm near Berwick where the slate roof was stripped off the beautiful, listed Victorian steading exposing the traumatised young cattle within to the raining debris and the elements. Fortunately no animals were hurt, but they (80 or so of them) had to be prematurely sold because they were effectively homeless. Slates from this incident were found 100 yards away from the shed. On the same farm a partial asbestos roof crashed down on the contents of the grain store containing 600 tons of oil seed rape valued at £650 per ton. This has all had to go to land fill as it is contaminated and no longer fit for human consumption. Two farms away a roof came crashing down on a tractor and brand new combine costing well over half a million pounds.

Whole woods were flattened in scenes reminiscent of apocalyptic nuclear attacks. At Prendwick near Whittingham five entire woods were flattened. Where some folk can say they've had four or five trees over, the farmer there can say he's had five entire woods blown over! Unfortunately these were only covered for fire damage. Uprooted trees at the edges of woods have caused fences to be 14 feet in the air and obviously fences everywhere have been ruptured. Mayhem.

Nearer to home Eglingham became cut off. We had friends who'd driven up from Taunton, told their daughters they were having a hell of a journey, arriving with us 10 minutes after the electric went off but as far as their frantic daughters were concerned, under a tree. We had a great boozy night with them in front of the stove as Arwen raged, plugged in an old land line phone, which amazingly worked, and were able to reassure their family



all was fine. They planned to leave early, and did so only to return in 10 minutes to say the village was entirely blocked off. We went to the top of the village with chainsaws to help Adam and Chris unblock the village and spent the rest of the day helping to cut folk out. Exciting stuff, not the weekend they were expecting.

Many though have much worse tales to tell with electricity being off for, in some cases, nearly a fortnight. National Grid did their best to disseminate information but with electric off, therefore no internet and mobile masts off, they might as well have used town criers. The National Grid men on the ground though, were terrific, and considering the severity of the storm and the remoteness of the terrain, have done a great job. Stories like National Grid sending fish and chip vans to remote communities like Harbottle to distribute free meals are heart warming. Going forward Eglingham

Parish Council would like to encourage our village hall committees to consider buying and installing (using wind farm money to fund it) emergency generators so we have community hubs should weather events such as Arwen happen again which, with Climate Change, is far from impossible. As I write this Storm Malik rages!

The loss of those lovely beeches at the top of the village and elsewhere all over our part of the country would make one weep. This extratropical cyclone came directly from the North, a very unusual direction for 100 mph winds. Apparently, because trees expect (they can think you know!) winds largely from the west, the north side is where their roots are at their weakest. Strangely many pine trees were snapped off like match sticks ten feet up.

Tragically there were three fatalities, but considering the severity of the event, only three. Had the storm taken place during the middle of the day we'd have all been running around like headless chickens trying to shore things up and, as exemplified with the slates near Berwick, people could have been decapitated. It could have been much worse. Luckily we were all mostly tucked up in front of our stoves with a glass of whiskey.

Minutes of the meeting of Eglingham Parish Council held on 24 November 2021
At Eglingham Village Hall
Present: Cllrs D Biesterfield (DB), J Lawson (JLa), J Hamilton (JH), R Faulkner (RF), J Logan (JL)

In Attendance: Clerk – Angela Meek, County Councillor Wendy Pattison

#### Apologies for Absence - Aaron Blackmore

In the absence of the Deputy Chair A Blackmore, JL proposed that DB chair the meeting. Seconded by RF.

#### **Election of Chair and Deputy Chair**

Following the resignation of Andy Gray as Chair and a member of the Parish Council, JL proposed DB as Chair of the Parish Council. This was seconded by RF. DB was duly elected as Chair. (Subsequent to the meeting AB confirmed that he was willing to continue as Deputy Chair)

#### **Matters Arising**

**Henry's Tree:** noted the outcome of the consultation on spending the balance of the donations, and that £6.15 remained which would be given to the Alnwick Food Bank as part of the Council's next donation.

**Repair of Litter Bin, South Charlton:** RF/JLa would liaise with A Gray about progress and report back at the January PC meeting. RF/JLa

Eglingham Village Hall Sign: the Clerk would request an update from Judith Scott. Clerk

**Application 21/03872/COU Middlemoor Narrow Boats Chathill:** DB had queried with NCC the location of the site. The Clerk would follow up. Clerk

**Tree Planting on Community Field:** AB's report was received and noted that ECA had drawn up plans on area and design for planting trees which would not disturb the drainage system. AB to submit plans at the next meeting. AB

**Demonstrations on use of Defibrillators:** agreed that JL would provide options to the January meeting on provision of defibrillator demonstrations to each village and on First Aid courses. JL

**Parish Council Insurance:** noted the position as outlined in DB's report and resolved to review the PC's insurance position and insofar as appropriate to rationalise it.

**Traffic Concerns:** noted that DB and JH would meet representatives of NCC on 10 December to see what the scope of action was, and then decide further action. Members raised the need to be aware of the potential impact on trade of any action taken, and of alternative routes used. DB/JH would report to the January meeting. DB/JH

**Jubilee Parish Picnic:** noted that ECA would arrange an event on 4 June on the Community Field for the Parish

**Meeting with NCC's Leader:** Dates of PC meetings have been provided to NCC Civic Heads' PA for scheduling a meeting.

**Eglingham Road Signage and Markings:** the response from NCC Highways was noted to the effect that no action was possible due to Eglingham being a built-up village with a 30mph speed limit and drivers were expected to know they could encounter pedestrians and should drive accordingly.

**Dog Litter Bin at Eglingham:** noted the possibility of an added enclosure around the bin at Tarry with a dog litter bin on the outside. DB to explore options and report to January meeting. DB

Great North Air Ambulance Service: agreed donation of £25. Clerk

**Certificate of Compliance:** noted the PC's Solicitors have advised that they are still waiting to hear back from the solicitor acting for the other party. The Clerk will write GL to advise further action is in their hands. Clerk

#### Precept Setting for 2022 – 2023

The item was deferred. DB and Clerk to discuss and report to the January meeting. DB/Clerk

#### **Vacant Councillor Positions**

The Parish Council agreed that DB and AB would arrange to meet Alyson McGarrigle and invite her to the next PC meeting. DB/AB

The Parish Council agreed to the co-option of Adam Wilson.

#### **Suggestion Boxes**

- a) First Aid Courses discussed under item 128/21.
- b) North Charlton Bus Shelter conversion to Library: JH reported for information that Highways England would be willing to consider its refurbishment. A detailed proposal and costings were requested by the PC and JH was asked if she was willing to take the matter forward. In light of her other commitments, the matter was deferred pro tem.

#### **Eglingham Parish County Councillor's Report**

The PC received the reports for November and December.

- a) The work of Communities Together was noted by the PC and highly commended. The item would be added to Hearabouts magazine. Clerk
- b) The A1 proposals were noted and that the Secretary of Sate was to approve them in January 2022.
- c) Queen's Jubilee there was to be funding available from NCC for a "Big Lunch" on 4 and 5 June 2022 to support street parties. The PC would be able to access funds. The Clerk would inform Eglingham Community Associsation through Malcolm Angus. More details to follow from NCC. Clerk

**Eglingham Local Plan** - Report from DB received and noted.

**Local History Project** – Report from JH received and noted.

**Biodiversity Study** – JL reported that all 11 residents have granted access to their land and the study would progress. The results would be provided to the PC prior to publication.

**Broadband Project** – JL reported that he had made enquiries with residents about who had broadband. Investigations revealed that the majority had made their own arrangements. The PC agreed that JL would draft an item for Hearabouts magazine and invite residents to come forward if they needed help in obtaining broadband. If no response was received, it was proposed that the item be closed.

#### **Planning Matters**

Planning application 21/03157/FUL – extensions and alterations to bungalow Fernlea 2 Ditchburn Road South Charlton – noted that permission had been granted.

**Community Field Goalposts** – The PC noted that Gordon Leishman was intending to replace the goalposts by applying for a CF grant. He would liaise with ECA.

**Street Lighting in Eglingham** – noted that AB had been approached by April Potts about the possibility of reducing the amount of streetlighting in Eglingham.

The PC agreed that DB would make enquiries. DB

JH raised concerns about the lack of community engagement and asked that when considering matters which directly affect residents, such as streetlighting, the PC consulted residents through Residents@ and Hearabouts. This was due to Members not being elected and not having a mandate.

**Additional Community Foundation Grant** – Tennis Pavilion – noted that there had been a shortfall of £1500 in the original application. The PC agreed that JH would submit the application with the Tennis Club in the PC's name with a copy of the application to be filed with the Clerk. JH
